# Attachment: President's Report

At the end of my first year as President of ITS Australia, I am excited to update you on the incredible program of activity we have delivered in 2024 to support our members across Australia's diverse intelligent transport sector. I begin by thanking the organisations that have renewed their membership this year and welcome the many new members who have joined our community, we look forward to engaging with you in 2025 and beyond.

### A New Strategic Vision

This year, we were proud to release our new Strategic Plan 2024 – 2029, guiding the association's activities for the next five years. The new Plan, which was developed by our engaged board directors and senior staff, considered the feedback from a members' survey in early 2024 and involved a big-picture look at our industry and the external factors likely to be of influence in the years ahead.

The Plan is underpinned by our vision that 'transport is safe, sustainable, productive and accessible through the application of technology'. Those key messages carry through to our defining purpose, which advocates for the use of technology to underpin a transport future that is seamlessly connected for all, efficient, harmonised, powered by a thriving industry, and embraced by society. These strategic priorities will be evident in our day-to-day work in 2025 and beyond, through activities like our expanded policy and research agenda, a third intake of our mentoring program, and our participation at important global events.

### **New Initiatives**

We regularly reflect on our membership offering, looking for new and innovative ways to provide excellent value to our members. In 2024, we were excited to announce two new initiatives.

In July, we announced the inaugural 'Woman of the Year' Award to complement the prestigious Max Lay Lifetime Achievement Award as the marquee recognition at the annual ITS Australia Awards. The introduction of the new award reflects that women have historically, and continue to be, underrepresented in the ITS industry. In establishing this new award, we aim to celebrate and elevate the increasing impact of women in our sector, ensuring their remarkable achievements receive the visibility they rightfully deserve.

Also this year, we announced our first-ever Careers Expo – offering current university students the opportunity to dive into the dynamic ITS sector by spending a day at the prestigious ITS Australia Summit. More than 100 students from our NSW-based member universities registered for the Careers Expo, exceeding our original expectations. They interacted with a broad range of potential employers from Government and industry, all actively looking to recruit the next generation of future leaders and attending two specially curated panel discussions showcasing ITS careers from both the employer and early career



professional perspectives. The Careers Expo is the latest ITS initiative in our efforts to grow and advance a thriving ITS industry in Australia.

### Policy, Advocacy and Research

In 2024, we accelerated our policy and advocacy efforts, underpinned by an expanded research program. We are currently involved in four concurrent projects, collectively partnering with more than 20 state and federal government agencies across the country.

Two research projects are concluding in the coming months with final reports to be released imminently:

The 'Integrated Connected Data for Safer, More Efficient Traffic Management Operations' project led by a multi-party government team wrapped up in late 2024. The project has identified significant opportunities for traffic managers to use existing data to improve road networks including reducing traffic delay at intersections, public transport signal priority, better use of signal control and variable speed limit and many more. These are real world opportunities that can be used on our roads today to improve traffic flow and reduce congestion.

Also to be published before the end of the year is the refreshed 'Guidance for Accessible EV Charging Infrastructure' led by Austroads, iMOVE Australia and La Trobe University. Under the guiding principle that EV charging should be a positive for all users, including people with disabilities and older people, the guidance is regularly updated to aid road managers, and to prompt consideration of issues relating to planning and design.

We were excited to join two new research project teams in 2024:

The collaborative iMOVE research project, 'C-ITS National Harmonisation and Pre-Deployment' which centres around deploying C-ITS around 30 intersections across five key corridors in the inner suburbs of Melbourne. This rollout of C-ITS at scale in a real-world busy urban environment will allow assessment of benefits, deployment considerations and options, and provide recommendations that could support Australian road authorities' adoption of C-ITS in a nationally harmonised manner.

Behavioural Change for Sustainable Transport – this new iMOVE project involves the University of Sydney and the Federal and Queensland Governments. This research aims to uncover attitudes and actions most likely to deliver actual change to a more sustainable transport system. It will make recommendations for policy-makers and operators to expedite those changes as well as investigating the economic impacts to deliver more sustainable transport initiatives.

As always, we continued to engage with the Federal Government, supporting their important policy work and ensuring our members are fully informed about key industry consultations. This included co-hosting an Industry Briefing Webinar and making a submission for the National Road Transport Technology Strategy and draft 2024–27 National Connected and Automated Vehicle (CAV) Action Plan. We also made a



submission during the Government's consultation on a New Vehicle Efficiency Standard (NVES) and kept the sector informed of other opportunities over the year.

### **National Events Program**

In February, we began our year with the largest-ever ITS Australia Awards at Sofitel Brisbane, with more than 300 people gathering for a night of celebration, recognition, and networking. The gala event was a great backdrop for awarding the best of ITS innovation across a range of categories, including connected and automated vehicles, transport data, and intelligent mobility.

We returned to Brisbane in March for our annual Roads, Tolling and Technology Conference where experts gathered for two days of insightful presentations and discussions. One big takeout from the conference was an overwhelming desire from industry and government to simply get on with it and work together to deliver important new infrastructure and technology to enhance our road networks.

In May, our annual Mobility Conference was the setting for a critical exploration of the role of mobility in Australia's transport landscape. Attendees were challenged to consider reimagining and broadening Mobility as a Service to 'Mobility as a Feature' to fully realise a holistic multi-modal transport future. It was a thought-provoking two-day discussion with data and technology, and sustainable transport standing out as major conversation starters amongst an engaged audience.

Following the success of the Global Summit in 2023, our annual ITS Summit in August continued to enjoy strong international support, with representatives from all eleven ITS Asia Pacific member associations joining us in Sydney for the industry's flagship event. The outstanding participation sends a powerful signal that our region is united in our ambition to solve many of the global transport challenges through the rollout of intelligent, technology-based solutions. Over 700 delegates engaged with around 200 speakers across 40 sessions covering safety, sustainability, and inclusivity. It was wonderful to see active engagement from the State's Road Minister, John Graham, who not only addressed delegates in our closing plenary but participated in a CAV Technical Tour. In his keynote address, Minister Graham acknowledged the importance of Governments' understanding of the myriad of ways in which technology can advance our transport systems and encouraged the sector to continue bold collaboration.

Finally, over the year, we continued our popular program of Business Networking Events – this year, we visited Adelaide, Brisbane, Melbourne, Perth, and Sydney - connecting our members and welcoming other industry professionals into the fold and promoting the benefits of our membership offering. Thanks especially to Telstra, SAGE Automation and University of Melbourne who supported these gatherings by hosting members at their offices.

### International engagement

It was another busy year engaging with the international ITS community, beginning in May with the 19th ITS Asia Pacific Forum, held for the first time in Jakarta. We were pleased to represent our members at



this important international event and host Australian delegates and leaders from the Asia Pacific at our VIP Networking event. We also participated in the Asia Pacific Board meeting, and I was pleased to join ITS Indonesia President William Sabandar to sign an MOU between our two associations.

In June, CEO Susan Harris and International Ambassador Dean Zabrieszach travelled to Auckland for ITS New Zealand's T-Tech 2024 Conference, where it was enlightening to learn about local solutions to some of our industry's biggest challenges and to bring those insights back to Australia. Susan joined a panel of international ITS associations, providing an overview of our dynamic policy and research agenda and industry engagement activities. This conference has once again provided a valuable opportunity to network with many of our members working in New Zealand.

To close out the year, we led a strong Australian delegation to the Dubai ITS World Congress, which was the first time the world's largest transport technology event had been hosted in the UAE. There was an impressive cohort of Australians represented in the busy 5-day program including speakers from Transurban, QUT, Main Roads WA, HMI Technologies and many more. We were honoured to have the Australia Consul-General to Dubai, Her Excellency Bryony Hilless deliver the keynote address at our well attended VIP cocktail reception and joined several important board meetings with our association colleagues from across the globe and a special bilateral meeting with our colleagues from the American Association of State Highway Officials.

### **Industry Growth**

A key pillar of our new strategic plan is supporting a thriving Australia ITS industry and ensuring our sector is internationally competitive and supported by solid career pathways from entry-level to leadership. As mentioned in my introduction, our first-ever Careers Expo is our latest activity focussed on attracting the best and brightest into ITS careers. Beyond talent attraction, we continued to support two activities – our NextGens Committee and Mentorship Program – which support career progression for those already in our industry.

Our ITS Australia NextGens – a group for young industry professionals, began the year with a new Committee and immediately got to work planning a solid program of online and in-person activities. Highlights from 2024 include very popular behind-the-scenes tours of the NSW Transport Management Centre, the Transurban Queensland Network Operations Centre, and a fascinating virtual tour of the SA Traffic Management Centre. This year, we elevated the profile of our NextGens at our business networking events, with a local committee member presenting at each event. They were also front and centre at Summit, participating in the bespoke sessions targeted at university students as part of the Careers Expo. As we close out the year, the Committee has just hosted its first Outback ITS webinar, spotlighting ITS solutions in regional and remote areas nationwide.

Our Mentorship Program, which matches mentees seeking an opportunity to grow personally and professionally with more experienced mentors from the industry, finished its second intake this year, and



as we end 2024, we have opened applications for the third intake to begin early in the new year. The feedback from participants at both ends of the career spectrum continues to be overwhelmingly positive. For our third round of the program, we're encouraging mid-career professionals to consider a mentoring role to build their expertise and realise their leadership potential.

### **Looking Ahead**

With a new year beckoning, ITS Australia is ready to roll out another engaging program of activity to support the all-important industry collaboration that members value so highly. Of course, we will continue to innovate – ensuring all member offerings remain fit for purpose and we'll offer new and exciting activities aligned with our Strategic Plan.

Such innovation begins in February when we host the first ever 'West Australian ITS Showcase,' a series of engaging and educational events taking place in Perth two days into the 15th ITS Australia Awards Gala Dinner. The showcase will include technical tours, presentations, workshops and networking activities, all designed to maximise the value of a visit to Perth for the Awards – where it is being hosted for the first time.

I want to thank the outstanding ITS Australia team, who continually deliver this impressive program of work with great passion and dedication, as well as my fellow directors on the Board, who continue to contribute great ideas and expertise that support the smooth operations of our association.

Finally, thank you again to our wonderful members – old and new – for your support of ITS Australia. Our efforts only succeed through the strong participation of our members, and we acknowledge the vital role you play in realising our vision that transport is safe, sustainable, productive and accessible through the application of technology.
